Loan Programs: Payment Deferrals & Low-Interest Loans

In response to the current COVID-19 crisis and its impact on business, LCNB National Bank is offering to defer certain loan payments for up to 60 to 120 days for the most seriously-impacted categories of business borrowers, as listed below. Current business borrowers in these business categories who have loans with LCNB and wish to request relief are encouraged to call their relationship officer to discuss these deferrals or working capital options. If your business has been impacted but is not within the categories below, you are welcome to email your relationship officer to discuss your current situation. Additional business categories may be added to this list as the impact of the crisis becomes more defined.

Government sources such as the SBA are also announcing their own special programs to be a support to business during this time. A link to these helpful SBA options is also included below.
