LCNB National Bank is first and foremost a community bank. That designation is not merely one defining the size of our institution, but one that defines our mission. We look to serve our communities and the people and organizations within them not only by providing accessible financial services, but by providing support in many ways.

Community and Charitable Support during COVID-19

Of course, 2020 was a year unlike any other in recent memory. The emergence of COVID-19 during March increased the needs within our communities, changed the types of assistance that were being sought, and impacted the ways through which support could be delivered. LCNB reacted quickly through a rapid-response approach. Contributions that would have normally been made later in the year, like those tied to an annual event, were instead made during the early days of the pandemic, the

greatest time of need. In addition, LCNB made emergency donations in April to chapters of the Ohio Association of Foodbanks that serve counties within our footprint, to the United Way network, and to the YMCA, earmarked to provide childcare for front-line workers. LCNB employees were also mobilized through Warren County Community Services to aid in the handling of donations made from food banks to seniors in need.

LCNB's Activities under the Community Reinvestment Act

LCNB National Bank holds an overall Community Reinvestment Act (CRA) rating of Satisfactory from its May 13, 2019 assessment, the Bank's most recent by its chief regulator, the Office of the Comptroller of the Currency (OCC). The three primary areas of assessment (lending,

investment, and service) all scored as High Satisfactory. LCNB makes "a good distribution of loans among individuals of different income levels, and businesses and farms of different sizes." LCNB "has also made a relatively high level of community development (CD) loans."
